Assumption of the Risk and Waiver of Liability Relating to Coronavirus/COVID-19

NOTICE

The novel coronavirus, Coronavirus/COVID-19, has been declared a worldwide pandemic by the World Health Organization. Coronavirus/COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments, and federal and state health agencies recommend social distancing and have, in many locations, limited or prohibited the congregation of groups of people. Dog Agility Association of the Ozarks (DAAO) has put in place preventative measures to reduce the spread of Coronavirus/Covid-19 for all their dog trials, including participation as an exhibitor, spectator or as a volunteer. However, DAAO cannot guarantee that you or your families will not be exposed to or become infected with Coronavirus/COVID-19 while at DAAO trials. Further, participating in DAAO trials could increase your risk and your dog(s)'s risk of contracting Coronavirus/COVID-19.

LIABILITY WAIVER

By signing this agreement, the undersigned acknowledges the contagious nature of Coronavirus/COVID-19 and voluntarily assume the risk that my dog(s) and myself may be exposed to or infected by Coronavirus/COVID19 while at DAAO's trials and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by Coronavirus/COVID-19 as outlined by the Center for Disease Control and the Missouri Department of Health and Senior Services and I acknowledge I have reviewed the same. I further agree to abide by all rules and protocols of DAAO relating to Coronavirus/COVID-19 safety.

With full knowledge and appreciation of the risks and responsibilities outlined in above, I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury or illness to my dog(s), and/or myself (including, but not limited to, personal injury, disability, and death) arising out of or relating to Coronavirus/COVID-19 exposure/infection that I, or my dog(s) may experience or incur in connection with our physical presence at DAAO's trials. I hereby release, discharge, and hold harmless DAAO, its board of directors, agents, and representatives; Lake Country Soccer, its agents and representatives; and The American Kennel Club, its board of directors, employees, agents, and representatives, of and from the any and all claims (including but not limited to claims of liability and damages) of any kind arising out of my voluntary participation and presence at DAAO's trials. I further agree to defend and indemnify the released parties for any and all claims brought by a third party which arise from my, or my dog(s)' attendance at DAAO's Trials as it relates to Coronavirus/COVID-19. I understand and agree that this release includes any claims based on the actions and omissions of DAAO, its board of directors, members, volunteers, agents, and representatives, whether Coronavirus/COVID-19 exposure/infection occurs before, during, or after being at DAAO's Trials.

In the event DAAO deems it necessary to employ legal counsel to protect its rights under this agreement and the court finds in favor of DAAO, I agree to indemnify and pay all attorney's fees and cost incurred by DAAO in connection pursuing or defending any claim arising from this agreement.
